Dear Chair Williams and Ranking Member Velázquez,

On behalf of the organizations and individual companies listed below, we are writing to express our support for H.R. 2804, the “Protecting Small Business Competitions Act of 2025.” Codifying the Rule of Two into law will both preserve small business competition and allow small business government contractors to successfully enter, compete, and remain in the industrial base.

While the Rule of Two has been in place for decades and confirmed by the courts, we believe this legislation is necessary and timely to ensure the government’s acquisition rules continue to allow small businesses to compete for and win a fair proportion of government contracts. In a marketplace that consistently uses large buying vehicles, protecting and empowering small businesses is good policy and essential for their continued participation. Through codification of the Rule of Two, this bill:

- Maintains fair competition for small businesses by eliminating ambiguity in procurement practices, thereby enhancing their ability to succeed and stay active in the federal marketplace.
- Enhances competition and allows the government to recruit and retain the small enterprises that bring new solutions, innovation, and talent to government missions.
- Promotes economic growth by providing small businesses with predictability and stable revenue streams, helping them grow, hire, and contribute to the local economy.

Over the past 10 years, the number of small businesses winning federal contracts has decreased by 50 percent. Additionally, nearly 60 percent fewer small businesses are entering the federal marketplace. The codification of the Rule of Two is critical to preserving the nation’s industrial base, thus ensuring America’s long-term economic resilience and competitiveness. We urge the Committee on Small Business to mark up and swiftly pass this crucial legislation.
